

CORPORATION OF THE TOWNSHIP OF EAST GARAFRAXA

BY-LAW NUMBER 47-2007

A BY-LAW TO AMEND BY-LAW 07- 2007, BEING A BY-LAW TO REGULATE THE PROCEEDINGS OF THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF EAST GARAFRAXA AND THE BOARDS AND COMMITTEES

WHEREAS Section 270 of the *Municipal Act, 2001, c.25* identifies that the Council of local municipality shall adopt and maintain policies with respect to the circumstances in which the municipality shall provide notice to the public and it notice is to be provided, the form manner and times notice shall be given;

AND WHEREAS the Council has deemed it appropriate to comply with the legislation by amending By-Law 07-2007, being a by-law to regulate the proceedings of the Municipal Council of the Township of East Garafraxa and the Boards and Committees thereof;

NOW THEREFORE THE CORPORATION OF THE TOWNSHIP OF EAST GARAFRAXA BY ITS MUNICIPAL COUNCIL ENACTS AS FOLLOWS:


1. THAT Section 3.6 Notice of Meetings be amended by adding the following paragraph:


The form, manner and times when notice will be provided to the public regarding specific by-laws and the holding of certain meetings is outlined in Schedule "A" to this by-by-law.

2. This by-law shall take effect and come into force and effect upon passing.

Schedule "A"

NOTICE PROVISIONS

Notice will be given for the following in accordance with the Municipal Act, 2001, or Township By-Laws, or any other applicable legislation as required but not listed. Where Provincial legislation prescribes that notice shall be given and the time and manner of notice, those provisions shall prevail. Where Provincial legislation prescribes notice must be given, but does not prescribe the time and manner of notice, or when deemed necessary by Council, the provisions of the Notice By-Law shall prevail.

- ▶ Temporary closure of a public highway
- ▶ Permanent altering of a public highway
- ▶ Change of name or naming a private road
- ▶ Shut off of Public Utility
- ▶ Sign By-Law
- ▶ Election Sign By-Law
- ▶ General Licensing By-laws
- ▶ Township policies and procedures pertaining to Sale and other disposition of land; Procurement of goods and services; Accountability and Transparency; Delegation of powers and duties contained within the Municipal Act or the Planning Act; and/or Hiring policies
- ▶ Restructuring proposal
- ▶ Name change of Municipality, and other Corporation changes, ie., adoption of flag
- ▶ Change to composition of Council
- ▶ Business Improvement Area
- ▶ Wards-re-divide or dissolve
- ▶ Procedural By-Law (including Notice requirements)
- ▶ Sale of Land procedures
- ▶ Adoption or amendment to budget
- ▶ Financial Statements
- ▶ Agreements for municipal capital facilities, Notice of Tax Exemption By-Law
- ▶ Prescribed notice of Fees and Charges By-Law
- ▶ Taxes on eligible properties
- ▶ Notice of Tax Bills
- ▶ Determination of tax status
- ▶ Seizure of personal property – Public Auction
- ▶ Division of Land
- ▶ Cancellation, reduction, refund of taxes
- ▶ Overcharges caused by a gross or manifest error
- ▶ Increase of taxes as a result of any undercharged caused by a gross or manifest error
- ▶ Notice of Registration of tax arrears certificate
- ▶ Public Sale – Tax arrears certificate
- ▶ Power of entry exercised
- ▶ Collection of unpaid licensing fines
- ▶ Closing premises – Public Nuisances
- ▶ Any other matters as deemed appropriate by Council
