### BY-LAW TO AMEND BY-LAW 2-95, BEING A BY-LAW TO REGULATE AND LICENSE DOGS IN THE TOWNSHIP OF EAST GARAFRAXA BY ADDING A SCHEDULE OF SET FINES

- 2. Schedule "A" of By-law 2-95 shall be effective upon the approval and/or amendment of Schedule "A" of this by-law by the Regional Senior Justice of the Ontario Court of Justice.
