At the end of the investigation, the Integrity Commissioner will report to Council about whether the Council Member(s) contravened the Code of Conduct. The Integrity Commissioner may disclose in the report such matters as in the Integrity Commissioner's opinion are necessary for the purposes of the report. Reports to Council become public documents.
