

The Corporation of The Township of East Garafraxa

By-Law Number 11-2021

Being a By-Law to amend Zoning By-Law 60-2004 as amended

WHEREAS the Council of the Corporation of the Township of East Garafraxa is empowered to pass By-laws to regulate the use of land pursuant to Section 34 of the Planning Act, 1990, as amended;

AND WHEREAS the owner of the property described as Concession 15, Part Lot 2, RP 7R5227 Part 3 and 7R5309 Part 1 (PIN 304082-0078 (LT)), Township of East Garafraxa has filed an application with the Township of East Garafraxa to amend By-law No. 60-2004, as amended, (Township File Z2-20);

AND WHEREAS it is deemed appropriate to amend By-law 60-2004, as amended, to rezone the subject lands;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF EAST GARAFRAXA ENACTS AS FOLLOWS:

1. The property being Concession 15, Part Lot 2, RP 7R6655 Part 2, be rezoned from Agricultural (A) to Rural Residential Exception Thirty-Six (RR-36).
2. Section 4.3.3 Exceptions Rural Residential (RR) Zone of Zoning By-Law 60-2004, as amended, is further amended by adding the following as Section 4.3.4.36:
4.3.4.36 **Rural Residential Exception Thirty-Six (RR-36) Zone**
(Concession 15, Part Lot 2, RP 7R6655 Part 2)

Notwithstanding the provisions of the Rural Residential (RR) Zone to the contrary, on lands zoned Rural Residential Exception Thirty-Six (RR-36) as shown on Schedule "A" hereto the following shall apply:

- i) a minimum lot area of 0.57 hectares; and
- ii) a minimum lot frontage of 15 metres; and
- iii) a minimum rear yard setback of 17.35 metres shall apply.

3. The property being Concession 15, Part Lot 2, RP 7R5227 Part 3 and 7R5309 Part 1, be rezoned from Agricultural (A) and Agricultural Exception One (A-1) to Agricultural Exception Eleven (A-11)
4. Section 4.1.4 Exceptions Agricultural (A) Zone of Zoning By-Law 60-2004, as amended, is further amended by adding the following Section 4.1.4.11:
4.1.4.11 **Agricultural Exception Eleven (A-11) Zone**
(Concession 15, Part Lot 2, RP 7R5227 Part 3 and 7R5309 Part 1)

Notwithstanding the provisions of the Agricultural (A) Zone to the contrary, on lands zoned Agricultural Exception Eleven (A-11) as shown on Schedule "A" hereto the following shall apply:


- i) New residential dwellings shall be prohibited.

5. In all other respects, the provisions of By-Law 60-2004, as amended, shall apply.
6. Schedule "A" to By-Law 60-2004, as amended, is further amended by rezoning from Agricultural (A) Zone to Rural Residential Exception Thirty-Six (RR-36) Zone, that part of (Concession 15, Part Lot 2, RP 7R6655 Part 2) and Agricultural (A) Zone and Agricultural Exception One (A-1) Zone to Agricultural Exception Eleven (A-11) Zone, that part of (Concession 15, Part Lot 2, RP 7R5227 Part 3 and 7R5309 Part 1,) identified on Schedule "A" to this By-Law.
7. This by-law shall take effect from the date of final passing thereof, providing no appeal has been filed pursuant to Section 34, Subsection (19) of the Planning Act, 1990, as amended.
