BY LAW NO. 12-81

TOWNSHIP OF EAST GARAFRAXA

THUNDERBIRD DRAINAGE WORKS

A By-Law to provide for a drainage works in the Township of East Garafraxa, in the County of Dufferin and for the borrowing on the credit of the municipality, the sum of \$ 78,000.00 being the amount to be contributed for completing the drainage works.

Whereas the requisite number of owners have petitioned the Council of the Township of East Garafraxa praying that the Thunderbird Municipal Drain be constructed and completed.

And Whereas the Council of the Township of East Garafraxa has procured a report made by Uderstadt Burnside Ltd., Consulting Professional Engineers, which report dated April 28th, 1981 shall be considered a part hereof.

And whereas the Council of the Township of East Garafraxa is of the opinion that the drainage works as described is desirable.

Therefore the Council of the Township of East Garafraxa pursuant to the Drainage Act enacts as follows:

- (1) The said report, plans, profiles, specifications, estimates and schedules of assessment are hereby adopted and the drainage works as proposed therein shall be constructed in accordance therewith.
- (2) The amount of \$78,000.00 necessary to be raised for such drainage works shall be made a cash assessment upon lands and roads affected by the proposed drainage works, with interest at the rate of 18% per annum added after the date payment is called on the same, provided that such sum shall be reduced by the amounts of grants and commuted payments if any, with respect to lands and roads assessed. Any amount remaining unpaid for a period of three (3) months shall be collected in the same manner and at the same time as all other taxes are levied and collected.
- (3) This by-law shall come into force on the passing thereof and may be cited as the "Thunderbird Drainage Works By-Law".
