Introduction

Schedule 22 of O. Reg 170/03 requires the preparation by the water system owner of a "Summary Report for Municipalities." This requirement only applies to large and small municipal residential systems. The Marsville Water Supply System is classified as a Small Municipal Residential Drinking Water System.

- 5. A summary of the quantities and flow rates of water supplied "including monthly average, maximum daily flows, and daily instantaneous peak flow rates." (Information is to enable the owner to assess the capability of the water system to meet existing and future demand).
- 6. A statement that captures the comparison of the flow information to the rated capacity and flow rates stated in the water supply's approval.

Flow control is in the form of a pressure reducing valve that is equipped to open and close when the well pump is energized. The valve limits the flow of water from the well. The well pump is also rated to pump less than 364 L/minute making it physically impossible to exceed the flow rate specified in the Permit to Take Water.
