Township Office and Hall Information

Final Tax 2022 Installment Dates

August 18th and November 17th

Penalty charges and interest on tax arrears are now being charged. Please call or email the Township to make tax payment arrangements.

Tax payments can be mailed or dropped off at the Township office or by debit in office. A secure drop box is available outside of the administration office, no cash in the drop box. Payments can be made via telephone or online banking, provided by most financial institutions.

Fire Permits

Fire permits are required, at no charge, for all burning within the Township. Fires are to be in accordance with Fire By-Law 7-2009. Please contact the Township office for more details.

All 2020 and 2021 valid fire permits have been extended for the year 2022. Please note that fire permits are non-transferable and are only intended for use by the person and property location listed on the permit.

Smoke & Carbon Monoxide (CO) Alarms

It is the law for all Ontario homes to have a working smoke alarm on every storey and outside all sleeping areas. CO alarms are required near all sleeping areas in residential homes, in the service rooms, and adjacent sleeping areas in multi-residential units. Official Plan Amendment No. 9 (OPA9)

A statutory public meeting was held concerning a Township Official Plan Amendment which proposes a number of revisions to the Official Plan. The proposed revisions are intended to assist the Township in its ability to process planning applications in a timely manner to enable the Township to provide decisions within the statutory timelines of the Planning Act as amended by the More Homes for Everyone Act, 2022.
