Taxation Information.

Tax payments may be mailed or dropped off at the Township office just west of Laurel, cash and cheques are accepted at the office. Secure drop boxes are available in Marsville and at the Municipal office location for after hour use. (No cash please). You may also make your payments via telephone or online banking services provided by most financial institutions. Search "East Garafraxa – Township of" as the vendor and quote your full

19 digit roll number (2201-000-00X-XXXXX-0000) as your account number. Please allow 3-4 business days for your payment to be processed in order to avoid late charges.

Should you have questions regarding your property assessment, please contact MPAC directly at www.mpac.ca or 1-866-296-6722. The deadline for submitting a Request for Reconsideration (RfR) is March 31st of each year, or 120 days from date of notice in a re-assessment year.

Planning Information

Township approval is required for all development. The Township Official Plan and Zoning By-law can be found on the Township website along with various planning applications. Development Charges are imposed under Bylaw 34-2014 for residential and wind turbine developments.

The Township is undertaking an Official Plan review for which public meetings will be held. Check the website and local newspapers for further information. The County of Dufferin now has a County Official Plan. For more information go to http://www.dufferincounty.ca/planning/

Any importation/ exportation of fill requires a Township or Conservation Authority permit prior to any alteration. Township fill permit applications must be requested in writing for



approval by Council in accordance with Site Alteration By-Law 14-2015 (available on Township website). Information to be provided shall include: reasons to place or remove fill; number of loads and depth of fill to be placed or removed; a site plan and cross section showing the location and measurements; a soil analysis report demonstrating that the soil is clean and suitable for the area and where the soil is coming from or going to. Additional information may be required, for more details please contact the Township office.
