## CORPORATION OF THE TOWNSHIP OF EAST GARAFRAXA

## **BYLAW NUMBER 39-2021**

## BEING A BYLAW TO AMEND BYLAW 26-2008, AS AMENDED, WHICH PROVIDES FOR ESTABLISHING RESPONSE FEES AND CHARGES FOR FIRE DEPARTMENT SERVICES

**WHEREAS**, the Municipal Act, 2001, S.O. 2001, provides that the Council may by By-Law impose fees for services and activities provided or done by or on behalf of the Corporation of the Township of East Garafraxa;

**AND WHEREAS**, it is expedient to impose fees for certain services provided by Fire Departments servicing the Township of East Garafraxa;

**AND WHEREAS**, the Orangeville Fire Department and the Erin Fire Department Fees change annually pursuant to applicable agreements;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF EAST GARAFRAXA ENACTS AS FOLLOWS:

1. That By-Law Number 26-2008, as amended by By-Law 23-2020, Schedule A, is hereby further amended by replacing the following under **Vehicle or Public Utility Incident Service Response Fees**:

1. Orangeville Fire Department

\$4,358.00 per occurrence

2. Erin Fire Department

\$3,784.00 per occurrence

- 2. That By-Law Number 26-2008, as amended by By-Law 23-2020, Schedule A, is hereby further amended by adding the following under **Vehicle or Public Utility Incident Service Response Fees**:
  - 3. Authorized Requester Information \$20.00 per request Services (ARIS)
- 3. That By-Law Number 26-2008, as amended, be further amended by replacing Section 2.2 with the following:

On every occasion where the vehicles, equipment and personnel of the Town of Erin Fire Department, the Grand Valley and District Fire Department or the Town of Orangeville Fire Department respond to a call or incident on any roadway in East Garafraxa Township under the jurisdiction of the County of Dufferin, and such call or incident involves a motor vehicle owned by a resident or non-resident, a fee shall be charged to the County of Dufferin, in accordance with the County of Dufferin policy. For incidents requiring the response of the Grand Valley and District Fire Department the fees as set forth on Schedule "A" which is attached hereto, and forms part of this by-law, shall be charged. For incidents requiring the response of the Town of Erin Fire Department or the Town of Orangeville Fire Department, the actual cost to the Township of East Garafraxa shall be charged.
